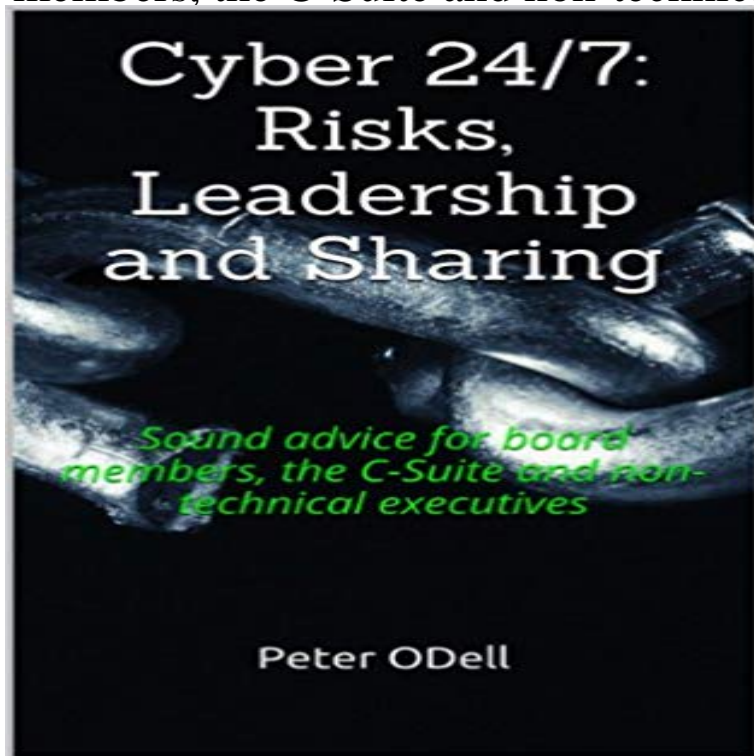


Cyber 24/7: Risks, Leadership and Sharing: Sound advice for board members, the C-Suite and non-technical executives
